## **The Purpose and Policy of the Minnesota Christian Convention**

The Minnesota Christian Convention is organized and operated as an exempt organization under 501(c)(3) of the Internal Revenue Code, and in particular, to promote the exchange of information, education, inspiration, and fellowship, among the autonomous Christian Churches/Churches of Christ in Minnesota.

Agencies and/or individuals that are promoting specific projects or services consistent with the aims of the Restoration Movement may use the Exhibit Area. All evangelistic, missionary, education, benevolent and journalistic agencies committed to the authority of the Holy Scriptures and the restoration of New Testament Christianity in doctrine, ordinances and life are welcome to make application for space to display their goods and services. Commercial exhibitors that have items needed in these areas of work and service are also welcome.

It is to be understood that the Minnesota Christian Convention is not in any sense an endorsing or promotional medium for any that exhibit. Each exhibitor will pay the appropriate rental fee for the space assigned by the Executive Committee of the Minnesota Christian Convention or its representative.

It is to be understood that if the Exhibitor uses music licensed by any licensing organization at its exhibit table, it will be responsible to pay the required fees to the licensing organization.

It is to be understood that it is the responsibility of the Exhibitor to pay all applicable sales taxes for materials sold at its Exhibit.
